TERMS

To insure the performance begins on time, the client agrees to:

- 1) Supply an area at least 11 feet by 8 feet for the DJ within 50 feet of a standard operating 110 volt AC outlet (15 amp minimum).
- 2) Make sure Travel Tunes personnel can begin set-up at least 2 hours prior to beginning of event.
- 3) Secure a direct route, clear of obstructions, from loading area to performance area.
- 4) Arrange to have two reasonably strong tables, 2 feet by 6 feet or larger, and one chair available for the D.J.'s use.

In the event these preparations are not made and the performance is delayed, Travel Tunes cannot compensate for time lost.

In the event the D.J. is unavailable to perform during the entire agreed upon time period, either due to travel, equipment or other unforeseen difficulty, liability is limited to providing the client with compensation equal to \$100 per hour for any unplayed time, from the scheduled D.J. play times previously agreed upon. The client commits to pay the total rate (from agreed start time to agreed end time) by the performance date.

In order to prevent liability resulting from accidental injury to any individual attending this performance, Travel Tunes D.J.'s reserve the right to deny any guest access to recordings or any equipment owned or leased by Travel Tunes. In the event the D.J. feels a hazardous situation exists, it will be the client's responsibility, upon notification, to take action to remedy the situation. If no action is taken, the D.J. may, in extreme instances, delay the performance until the situation is resolved. Travel Tunes assumes no liability for injuries to the client or guests.
